BUSINESS AND ECONOMIC IMPACT OF COVID-19 IN ZIMBABWE

According to a Survey done by CZI on the Impact of the Lockdown to the Productive Sector

The results of the survey have generally indicated that corporates across all sectors of the economy are under stress due to Covid-19 and policy responses to contain the pandemic. .

The loss of revenue has resulted in cash flow difficulties for the companies as they still have to meet their statutory obligations (Taxes, NSSA, Levies, NEC subscriptions, Rentals, Utilities etc) as well as paying wages and salaries for their employees. Companies are also incurring increased costs as they fight the spread of the corona virus at the workplace by providing protective equipment and reducing employee numbers to comply with social distance requirement. This implies a low income and high overheads business environment.

COMPANY SPECIFIC RECOMMENDATIONS

In view of the Covid-19 pandemic which is a natural disaster, companies need to review their business models in order to remain afloat and survive the difficult times. They may also consider the following;

- Tighter management of cash flows and liquidity.
- » Explore how operations can be restructured to minimize risk to employees, e.g. shiftwork with less people on site, in order to provide greater social distance between employees etc
- Enhance online presence since the global village is going digital.
