NSSA NOTICE TO EMPLOYERS

Following the gazetting of Statutory Instrument (SI) 108 and 109 of 2020 of the 15th of May 2020 pertaining to a review of NSSA CONTRIBUTION RATES AND MAXIMUM PENSIONABLE SALARY, THE Authority wishes to advise employers that these will be effective from 1 June 2020 as follows:

Pension and Other Benefits Scheme (POBS) - SI 108 OF 2020

CONTRIBUTION RATE	CURRENT UPTO MAY 2020	EFFECTIVE 1 JUNE 2020
	7 %	9 %
MAXIMUM PENSIONANABLE SALARY	ZWL 700	ZWL 5 000

The contribution rate is split equally between employer and employee, which means it has gone up by 1 percentage point for each from 3,5 to 4.5.

Accident Prevention and Workers Compensation Scheme (APWCS) - SI 109 OF 2020

The APWCS now caters for additional assistance to grossly disabled pensioners. Where a grossly disabled worker who is above 70 per centum disabled does not have adequate accommodation, the General Manager may provide rural dwellings for such worker and such dwellings shall be in a form and condition as determined by the General Manager from time to time.

Implementation Date

Considering the effects of the COVID-19 pandemic and in the interest of protecting jobs and enabling industries to thrive, implementation of the reforms will be with effect from 1 June 2020, **in**stead of 1

January 2020.

NSSA will soon be engaging its actuaries to conduct an actuarial valuation to determine the level of benefits that the scheme can afford to pay with implementation of the necessary reforms.

THE LAW GOVERNING PPPs in ZIMBABWE

Government promulgated the Joint Venture Act (Chapter 22:22) in February 2016 to regulate the implementation of PPPs.

The JV Act was repealed on the 7th of February 2020, paving way for the introduction of the ZIDA Act [Chapter 14:37]

ZIDA Act is now the new law governing the implementation of PPPs in Zimbabwe.

Public Private Partnership Unit (1)

The Joint Venture Unit established in terms of section 3 of the Joint Venture Act [Chapter 22:22] (No. 6 of 2015) in the Ministry responsible for Finance and Economic Development shall, on and after the fixed date, continue in existence and shall be known as the Public Private Partnership Unit of the Agency.

The Public Private Partnership Unit shall perform the following functions—

- (a) to consider project proposals submitted to it and assess whether or not they— (i) are affordable to the contracting authority; and (ii) provide value for money; and (iii) provide for the optimum transfer of technical, operational and financial risks to the counterparty; and (iv) are competitive;
- (b) Through the Chief Executive Officer, to make recommendations on such proposals to the Cabinet; and
- (c) to examine requests for project proposals to ensure they conform with the approved feasibility studies; and (d) to advise Government on PPPs generally; and
- (e) to develop best practice guidelines in relation to all aspects of PPPs; and (f) formulate suggested policy in relation to PPPs for adoption by the Government; and
- (g) to develop awareness of PPPs in Zimbabwe as a vehicle for economic development and delivery of public services; and
- (h) through the Chief Executive Officer, to make recommendations on project proposals submitted by contracting authorities to the Cabinet as to whether to approve or reject proposals; and
- (i) to undertake monitoring and evaluation of PPPs and, where necessary, through the Chief Executive Officer, to make appropriate recommendations concerning such projects to the Cabinet and contracting authority.
